As the week comes to an end, there was talk of both the House and Senate coming back for a Friday session. We now know this is not the case, but should be expected next week. Both Chambers were busy passing Resolutions, presenting executive nominations, and hearing bills in Conference Committees. The hopes of having a budget agreement were not met but the Governor, Speaker of the House, and Pro Tem of the Senate continue to work vigorously on this issue. We do see party lines being drawn when it comes to the budget and spending, making the flexibility in a decision that much tougher.

February 2, 2010 – Session Convenes

February 18, 2010 – Deadline for Reporting Senate Bills from Senate Committees (Senate)

February 25, 2010 – Deadline for Reporting House Bills from House Committees (House)

March 11, 2010 – Deadline for Third reading of a Bill in the House of Origin

April 1, 2010 – Deadline for Reporting House bills from Senate Committees (Senate)

April 8, 2010 – Deadline for Reporting Senate Bills from House Committees (House)

April 22, 2010 – Deadline for Third Reading of Bills in Opposite Chamber

May 28, 2010 – Sine Die of the second session of the 52<sup>nd</sup> Legislature
